Dear Tiller Days Enthusiast:

Vendor applications to participate in the 2019 Tustin Tiller Days Festival will be accepted on a first-come, first-served basis, and then must be approved by the Committee. This year's event will be held October 4-6, 2019, at Columbus Tustin Park, located at 17522 Beneta Way in Tustin. Attendance for this event is projected to be approximately 65,000 people over the three days.

**Commercial businesses and non-profit information vendors may apply for booth space beginning April 1, 2019.**

Please include a detailed description of items, products, and services that your group wishes to sell or promote. The Tustin Tiller Days Committee will review all applications, and vendors will receive notification of approval status 6-8 weeks after receipt of their application. In an effort to avoid duplication of items, the Tiller Days Committee has the right to decline an application.

The Board of Equalization (BOE) wants to make doing business in California as easy as possible. You can register for a seller's permit or use tax account online at [www.boe.ca.gov/electsrv/esrvcont.htm](http://www.boe.ca.gov/electsrv/esrvcont.htm) or in person at one of their field offices. Locations can be found by visiting [www.boe.ca.gov/info/phone.htm](http://www.boe.ca.gov/info/phone.htm). All vendors must obtain a seller's permit in order to participate in City events. This year, all commercial vendors will need to provide a City of Tustin Business License. If commercial vendors do not have a Tustin Business License, a temporary license may be purchased from the Business License counter at Tustin City Hall, 300 Centennial Way, Tustin, CA 92780.

If your application is approved, you will receive your Tustin Tiller Days information packet by mail, including the event layout, check in/check out procedures, and all other materials, no later than September 23. A limited number of booths are available. Submit your application, and all additional documents, with your payment today. We look forward to working with you at the 2019 Tustin Tiller Days Celebration.
