CERAMICS: Original work in clay or porcelain. No mass produced items accepted.

DRAWING/GRAPHICS/PRINTMAKING: Original works made with pen, pencil, charcoal, and traditional print making.

FIBER ART: Includes basketry, leatherwork, tapestry, silk, and papermaking.

FINE ART JEWELRY: All jewelry must be entered in this category. No commercial or mass produced items.

GLASS: All handmade glass excluding jewelry or mass produced items.

MIXED MEDIA: Two and three dimensional work that incorporates more than one type of material or media.

PAINTING: Oil, acrylic, watercolor, pastels, etc.

PHOTOGRAPHY: Photographic prints made from the artist's original images including digitally enhanced photography.

SCULPTURE: Three dimensional work in any medium.

WOOD: Original, decorative, or functional works made primarily in wood.

HANDCRAFTED ITEMS: Original handcrafted designs which do not fall into other categories on this application. No mass produced work, items made from kits, or commercially made objects that have been embellished. **HANDCRAFTED ITEMS MAY INCLUDE:** Accessories, jewelry, candles, pet items, crochet, embroidery, knitting, needlecraft, paper goods, quilts, toys.

This show is juried to ensure quality, balance, and variety. The Tustin Old Town Art Walk Committee selects the participating exhibitors and can approve or refuse any submitted works.

Exhibitor Spaces and Participation

Exhibitor sidewalk spaces are approximately 5' x 10'. Not all spaces will accommodate a 10'x10' canopy. **Prior approval is required for exhibitors setting up a canopy**, otherwise exhibitor will be asked to remove it. All umbrellas/canopies must be in good condition. Exhibitors are responsible for supplying their own exhibit set-up which includes: umbrella/canopy (if approved), chairs, tables, and display materials. Exhibitors are responsible for set up and tear down of their spaces. Spaces will be on hard surfaces. No electricity is provided. Exhibitors must remain in attendance at their space throughout the event.

Exhibitors accepted to participate must display their own original work. **Work displayed the day of the event must be same quality or higher as the images submitted with the original application. Exhibitors displaying work of lesser quality to what was approved will be asked to remove such pieces.** Prints must be reproductions of Exhibitor's original art and represent a minority of the work displayed. No reselling of mass produced items will be allowed. All work must be family appropriate.
