

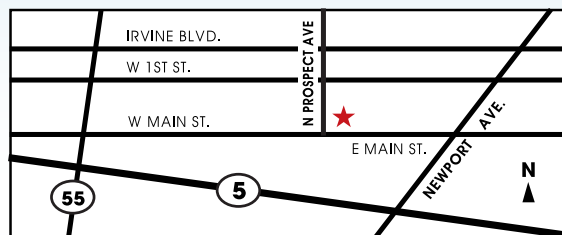

Household hazardous wastes (HHW) are products that are flammable, corrosive, reactive or toxic. **It is illegal to dispose of household hazardous waste in any CR&R waste and recycling container. This includes batteries of all types and sizes.**

PREPARATION

- Place all items in the trunk of your car
- It is illegal to transport more than 15 gallons or 125 pounds of hazardous waste in your vehicle (Department of Transportation Requirement)
- Do not mix products together
- Materials should be in original containers, clearly labeled
- All containers must have lids, be sturdy, non-leaking, labeled and protected from breakage
- Containers larger than 5 gallons will not be accepted

ACCEPTABLE ITEMS:

Hazardous Waste:

- Paint and painting supplies – latex, oil based, thinners, strippers, stains and finishes
- Automotive products – oil, antifreeze, brake and transmission fluid, and automotive batteries
- Cleaning products – drain cleaner, oven cleaner, pool chemicals, and bathroom cleaners
- Pesticides and herbicides – bug sprays, mouse and rat poison/bait, repellents
- Aerosol cans

Universal Waste:

- Electronics – TVs, computers, monitors, stereo equipment, DVD players, handheld electronics, cell phones, cameras, printers, scanners, fax machines, microwave ovens, game consoles/ accessories
- Household Batteries – AAA, AA, C, D, 9-volt
- Fluorescent tubes and bulbs (packaged to prevent breakage in transport)

ITEMS NOT ACCEPTED:

- Asbestos
- Business waste
- Explosives, ammunition, road flares, gasoline
- Radioactive materials
- Medical Waste or medical sharps (needles, lancets)
- Biological waste
- High pressure cylinders
- Pharmaceuticals, medication
- Propane tanks
- Helium Tanks

Sharps will NOT be accepted at the HHW collection event on May 6th, 2023. Need to dispose of sharps?

Sharps disposal mail-back containers are available upon request at no charge. To schedule the delivery of a sharps disposal mail-back container to your home, please contact our customer service department at 714.372.8272. Sharps disposal mail-back containers are also available at Tustin Pharmacy at 13400 Newport Avenue free of charge. Please show a valid driver's license or your current CR&R Bill as proof of Tustin residency.

If the holiday falls on a Saturday or Sunday, trash will be collected on your normal collection day with no delays to your pickup. If the holiday falls during the work week, collection for the remainder of the week will be delayed by one day. For example, if Independence Day falls on a Monday, and your normal collection day is on a Thursday, your pickup for that week will be on Friday.
