Narrative:

I am a Detective assigned to the Tustin Police Department Gang Unit. The Gang Unit provides saturation patrol resources in high crime areas such as the southwest area of Tustin. The Southwest area is a high-crime area prone to murders, robberies, sexual assaults, assaults with deadly weapons, burglaries, stolen vehicles, drug activity and gang activity. My responsibilities include, but are not limited to gang suppression, gathering intelligence, reviewing graffiti related offenses and the investigation of gang related crimes.

On Wednesday, April 24th, 2013, at approximately 2344 hours, Deputy Probation Officer Art Lopez and I responded to [REDACTED] regarding an assault with a deadly weapon incident. Upon arrival, I contacted the victim, [REDACTED] inside his apartment, [REDACTED]. I immediately noticed several visible injuries on [REDACTED]'s face, arms, hands, fingers and his knees. His injuries were photographed and later uploaded to TPD's computer system as evidence.

Victim's Interview ([REDACTED]):

I contacted [REDACTED] and asked him what happened. [REDACTED] told me his English was limited and he preferred to speak to me in Spanish. Based on the fact I am a City of Tustin certified Spanish Speaker I spoke to [REDACTED] in Spanish. This is a synopsis of what he told me:

██████ told me prior to the assault he was at his sister's residence (located on Pasadena Av and Altadena Dr) having a few drinks. ██████ left his sister's residence and began walking home. While in the north alley of Altadena Dr , ██████ was approached by a male subject (S-1) demanding \$2 dollars. ██████ said S-1 became upset after he declined to give him the money. ██████ said S-1 was then joined by two additional subjects (S-2) and (S-3). The suspects began punching and kicking ██████. Seeing he was outnumbered, ██████ feared for his safety and began running towards his apartment N/B through the west alley of Myrtle Av. The suspects yelled "Motherfucker" as they chased him up the staircase leading to his apartment.

██████ said the assault continued as he ran up the staircase. ██████ defended himself by kicking and swinging his fists at the suspects. ██████ said one of the suspects armed himself with a large concrete "block" and hit him with it causing injury to his body. ██████'s wife, ██████, came out of her apartment after hearing the commotion. The suspects fled the area on foot.

I asked ██████ if he could provide me with a description of each suspect. ██████ told me he only remembered the suspects as "Young" Hispanic males, approximately 505-506 feet. He said two of the suspects were wearing white t-shirts. ██████ said he thought the suspects were gang members.

██████ told me he believed the suspects lived in the area because they looked familiar. I asked him if he knew the names or nicknames of his attackers and he said, "No." As I continued asking ██████ further questions regarding the suspects' physical description, ██████ appeared reluctant to provide me with further information. I asked him if he was withholding information because he simply could not remember or because he thought the suspects were gang members. ██████ had a change of heart and told me even though he feared for his safety he would be able to recognize the suspects if seen again. Based on my training and experience, I know victims of gang crimes can sometimes be reluctant to provide suspect information when reporting a gang crime due to fear of retaliation by members of the gang.

██████ ***' Interview*** (██████)

I contacted ██████ and asked her to tell me what she saw. ██████' interview was also conducted in Spanish and she told me the following: ██████ was inside her apartment with her children, when she heard a commotion just outside her apartment. ██████ said she walked outside and noticed two suspects "Beating" ██████. ██████ said she saw one of the suspects hit ██████ with a brick. ██████ said a neighbor came to ██████'s aid and the suspects fled the area on foot.

██████ ***Interview (Witness):***

I contacted a neighbor, ██████ and asked her what happened. ██████ told me she was inside her apartment when she heard "Screaming" coming from outside her apartment. ██████ said the person screaming was ██████. ██████ said ██████

screamed, "Let him go. Let him go." [REDACTED] said [REDACTED]'s assault occurred at the top of the stairs. [REDACTED] could not provide me with any of the suspects' descriptions.

[REDACTED] Interview (Witness):

I contacted [REDACTED] [REDACTED] and asked her if she saw the assault. [REDACTED] said she was walking back to her apartment when she noticed two suspects fleeing the scene of the crime on foot. I asked her for a description of the suspects and she told me she did not get a "Good look at them". [REDACTED] said two of the suspects were possibly wearing white shirts and shorts.

DPO Lopez and I searched the area for additional evidence related to the crime and while searching the north alley of Altadena Dr, I located bag of potato chips in a black plastic grocery bag. Based on the possibility of the items belonging to the suspects, DPO Lopez and I responded to the King Liquor (17102 E. McFadden Av) store to review their surveillance video in an attempt to identify the suspects involved in the assault.

At the King Liquor store I was able to review the surveillance video. I noticed a male subject, later identified as Alberto Ramirez purchasing a bag of potato chips similar to the bag of chips located in north alley of Altadena. I noticed the time Ramirez purchased the bag was approximately 2330 hours, just 14 minutes prior to the assault of [REDACTED]. I obtained a copy of the video and including a still photograph in an effort to identify the suspects.

While at the location, at approximately 0120 hours, TPD dispatch received a call advising the suspects of the assault had returned to the area of the original crime scene, 15917 Myrtle. DPO Lopez and I returned to the scene and continued our investigation.

Based on the fact the suspects were possibly hiding in the area a perimeter was placed in an attempt to contain the suspects. Sgt. Cartwright arrived at the scene and airship was requested.

[REDACTED] Interview (Witness):

DPO Lopez was contacted by [REDACTED] [REDACTED] and she informed him "The same suspects returned to the area." [REDACTED] saw the suspects walking N/B through the west alley of Myrtle Av, approaching [REDACTED]'s residence. [REDACTED] said the suspects began flashing gang hand sign at them. The suspects then began to throw rocks at [REDACTED] and the group of people she was with. [REDACTED] does not know what gang the suspects belong to.

Female Subject (Anonymous):

While searching for the suspects, DPO Lopez contacted a female subject sitting in a parked vehicle in the west alley of Myrtle Av. DPO Lopez asked the female if she saw

the suspects in the area. The female subject told DPO Lopez she did not want to get involve out of fear of retaliation.

The female subject stated she lived in the area and could not provide us with any of her personal information. She expressed extreme concern for her safety and told us she wished to remain anonymous.

The female subject told DPO Lopez she was in the car when she noticed two suspects walk N/B through the west alley of Myrtle Av. She saw one of the suspects display gang hand signs as he walked towards 15917 Myrtle Av. She then said, "You guys just missed them." She said two suspects ran N/B between the apartments located on Altadena Dr. She then saw the suspects on the second floor running W/B towards [REDACTED] possibly entering apartment [REDACTED] or [REDACTED]

Search of [REDACTED]

Based on this information, DPO Lopez, Officers Jensen, Girgenti, Crough and I responded to [REDACTED] in an attempt to locate the two suspects. Officer Crough knocked on the door and [REDACTED] and [REDACTED] opened the door. In Spanish, I informed them we were looking for two suspects involved in an assault. I asked them for permission to enter their residence and search for the suspects. [REDACTED] and [REDACTED] gave me permission to enter their residence and look for the suspects. We searched the residence and did not locate the suspects.

Search of [REDACTED]

We then responded to [REDACTED] and contacted [REDACTED] at the front door. In Spanish, DPO Lopez informed [REDACTED] we were searching for two suspects involved in an assault with a deadly weapon incident and had information they possibly ran inside her residence in an attempt to hide. After hearing the reason for contacting her she allowed us to enter her residence.

While at the residence, Abel Andrade was located in the rear portion of the apartment.. Based on several contacts with Andrade, I know he is self-admitted member of the Lopers criminal street gang. Andrade is on active parole and on gang terms specific to Lopers gang. He has prior arrests for possession of a firearm including gang charges specific to Lopers.

I also noticed a male subject, previously identified as Marcos Cruz. Cruz was lying on the floor approximately 5 feet away from the front door. Cruz was not wearing a t-shirt and he appeared to be sleeping. Based on previous contacts with Cruz I know he is an affiliate of the Lopers criminal street gang.

I am familiar with the Lopers criminal street gang as defined by CPC 186.22. Based on my training and experience as a Tustin Police Department Gang Detective and in speaking with other Tustin Police Department Gang Detectives as well as other law

enforcement officers from neighboring agencies, I know associates, participants and members of the Lopers criminal street gang have been engaging in a pattern of criminal activity. The Lopers criminal street gang has common names, signs and symbols such as; Lopers, LPS, LPSR, VLPS, and VLOPERS.

*At this time, I would like to note on 03/27/13 at approximately 1700 hours, Andrade responded to TPD to register as a gang member. During the interview, he told me his address was [REDACTED] [REDACTED] I reminded him that Lopers was a criminal street gang and that the gang engages in a pattern of criminal street gang activity per CPC 18.22(e). He was also reminded the gang had demonstrated a pattern of participating in the commission, attempted commission or solicitation of two of more crimes of 33 crimes, some of the 33 crimes include, **assault with a deadly weapon, robbery, terrorist threats and felony vandalism**. He signed a step notice acknowledging he understood the advisement TPD RN#13-60.*

Interview of Abel Andrade at the scene:

I contacted Andrade and told him I needed to speak to him regarding an assault that had just occurred in the area and he agreed. DPO Lopez and I spoke to Andrade in an empty bedroom inside the apartment.

DPO Lopez and I visually inspected Andrade for physical injuries possibly sustained during the assault. Andrade had a small abrasion on both of his elbows, which appeared to have been sustained very recent. These injuries were later photographed and the photos were later uploaded to TPD evidence locker.

Andrade began by denying any involvement stating he was inside the apartment since 8am. I asked him a follow up question to confirm he meant 8am and he answered, "Ah, yeah." I told him an incident occurred on Myrtle and I needed to know if he was involved. Andrade became agitated, clinched his right into a fist and began punching his left palm. He then said, "I don't give a fuck."

I asked Andrade if I was to show witnesses a photo lineup containing his picture if he thought they would identify as one of the suspects involved. He answered, "Go ahead."

Andrade told me he recently moved to the location because he and his mother-in-law were having problems. Andrade's girlfriend lives at [REDACTED] He said he was been living in the apartment for approximately three days. Andrade said, "I told my parole agent. I texted him letting him know."

DPO Lopez asked Andrade if he was involved in the incident and Andrade said, "No." He stated he was not involved. He was asked if he ran into the apartment prior to us contacting him and he said, "No." Andrade said, "I been here the whole day." He said he was not stupid enough to "Do a jale" (commit a crime) in Tustin because it was not his neighborhood. He said, "This is not Santa Ana."

Based on the totality of the circumstance, the information gather during the entire investigation and statements made by witnesses, an in-field lineup was conducted.

Andrade was positively identified by witness [REDACTED] as one of the suspects involved in the assault. [REDACTED] stated he saw Andrade hit [REDACTED] and told him he (Andrade) as going to kill him. Andrade was arrested and placed in the back seat of my patrol unit. (See Officer Jensen's supplemental for details).

I then attempted to wakeup Cruz so I could asking questions regarding the assault, but he appeared to be sleep. I continued talking to him until he eventually woke up and sat on mattress on the floor. Cruz opened his eyes, looked at me and laid back down. Cruz then said something to me but I was unable to understand him because his speech was slurred. Cruz had a moderate odor of alcoholic beverage emitting from his breath.

Based on Cruz' inability or reluctance to cooperate with my investigation and the fact he was at the location accompanied by Andrade, a self-admitted member of the Lopers criminal street gang, fact two suspects involved in the assault were seen running inside apartment [REDACTED] or [REDACTED] and the fact Andrade had been positivity identified as one of the suspects involved in the incident via infield line up, I asked Officer Girgenti to assist me by escorting Cruz to the north alley of Altadena Dr for an infield lineup.

Officer Girgenti secured Cruz' right arm, while I secured his left arm. As we attempted to escort Cruz down the stairs he look to his left and said something in Spanish. I was unable to understand what he said due to him having slurred speech. I asked him to repeat what he said and he began cursing in Spanish. Cruz stopped walking and attempted to break free from my hold. I then attempted to place his left arm behind his back in order to possibly handcuff. I then suddenly noticed him break away from Officer Girgenti's hold. Cruz swung his right hand with a close fist striking me twice on the left side of my face.

I quickly let go of his left arm and defended myself by punching Cruz on his face with my right fist. Cruz continue throwing punches at me making contact with my head and my left ear area. Officer Girgenti attempted to grab Cruz from behind, but instead I noticed Cruz lunged toward me. Based on the fact we were fighting Cruz on the second floor near the railing and approximately 2-3 feet away from a series of steps, I pulled Cruz forward and bend his upper body towards me. I was then able to knee Cruz on his upper torso area. Officer Girgenti and I used our body weight to take Cruz to the ground in an attempt to end the fight. Cruz attempted to stay up by holding on to the railing, but he quickly lost his grip and fell to the ground. Officers Jensen and Crouch assisted us by placing Cruz in handcuffs.

Based on Cruz' decision to punch me on my face several times with his right fist, I arrested him for CPC 241(a) Assault on a Peace Officer. He was then escorted to the north alley of Altadena Dr where he was positively identified by witness [REDACTED] as a second suspect involved in the assault on [REDACTED]. [REDACTED] stated Cruz was the suspect who hit [REDACTED] with the "Block." (See Officer Jensen's supplemental for details).

Cruz sustained minor injuries to his facial area. OCFA/Paramedics responded to the scene and provided Cruz with immediate medical care. Officers Rojas and Crouch transported Cruz to Western Medical Care for medical clearance. Cruz was treated and released from the hospital. He was then transported to TPD for completion of booking paperwork.

██████████ was also placed in an infield lineup investigation, but was not identified as a suspect involved in the assault. He was released at the scene without incident. (See Officer Jensen's supplemental for details).

Prior to transporting Andrade to TPD, he kicked TPD Gang Unit (835) rear left window causing it to come out of its frame. I inspected the window for damage and noticed the window frame was damaged from being kicked. The damage does not allow the window to be operated as designed. Andrade was advised of the damage he caused to the unit and was informed he would be charged with CPC 594(a)(b)(1) Vandalism. He was later transported to TPD for completion of booking paperwork.

Andrade's Miranda Interview:

At TPD, I read Andrade his Miranda Rights from my department issued Miranda Advisement Card. Andrade stated, "Yes," to each Miranda question indicating he understood his Miranda Rights. Andrade waived (Implied waiver) his rights and told me the following:

I asked Andrade to tell me what happened. Andrade said, "Nothing happened." I asked him if he was outside the apartment at any point prior to his arrest and he said, "No." Andrade said he was sleeping at the time of the incident. Andrade continued denying involvement stating he was sleeping.

I asked Andrade if he was displaying any Lopers gang hand signs at any point and he said, "No." Andrade said he was no longer a member of Lopers. I asked him if he was jumped out and he said, "No. I walked out." I told him if he was still "Cool with the homies" and he said, "Yeah." Andrade stated he wanted to be housed with "The homies." This concluded my interview.

Cruz' Miranda Interview:

At TPD, I read Cruz his Miranda Rights from my department issued Miranda Advisement Card. Cruz stated, "Yes," to each Miranda question indicating he understood his Miranda Rights. Cruz waived (Implied waiver) his rights and told me the following:

I asked Cruz if he remembered being involved in a fight in the west alley of Myrtle Av and he said, "No." I asked him if he remember hitting the victim with a "Brick" and he said, "No." I asked him if he remembered anything prior to his arrest and he said, "No."

Cruz state he was extremely intoxicated and could not remember anything prior to his arrest.

I asked Cruz if he gets violent with he drinks and he said, "No I'm cool." I told him if he remembered punching me and fighting with TPD Officers and he said, "No." He said he would not fight officers if he was not drunk.

I asked Cruz if he knew Andrade was a member of the Lopers criminal street gang and he said, "Yeah." Cruz said Andrade is his friend, but he would not back him up during a fight. I told Cruz he and Andrade were seen assaulting the victim and fleeing the area on foot towards his apartment. Cruz denied involvement and continued saying he did not remembered anything.

Based on Cruz inability to remember what happened. I concluded my interview.

Alberto Ramirez' Arrest:

On 04/25/13 at approximately 1942 hours, I responded to [REDACTED] and contacted Ramirez. I asked Ramirez regarding the incident and he told me he was not involved. Ramirez stated on 04/24/13 at approximately 2330 hours, he went to the King Liquor and purchased some items, including a bag of chips. Ramirez stated he drove away from the scene and did not see or hear the assault.

A records check of Ramirez was conducted and an outstanding warrant was located. He was arrested for the warrant and transported to TPD for completion of booking paperwork.

Ramirez' Miranda Interview:

At TPD, I read Ramirez his Miranda Rights from my department issued Miranda Advisement Card. Ramirez stated, "Yes," to each Miranda question indicating he understood his Miranda Rights. Ramirez waived (Implied waiver) his rights and told me the following:

Ramirez told me he was not involved in the assault. He denied involvement and told me he was with his girlfriend at the time of the incident.

Property/Evidence:

The evidence collected during the investigation was later booked it at TPD evidence locker. Photographs taken during the investigation were later uploaded to the TPD computer system.

Andrade and Cruz provided me with a sample of their DNA via buccal swab and I later booked the samples at TPD evidence locker.

I digitally recorded my interview and uploaded them to TPD Puma system.

Recommendations:

Andrade was transported and booked into O. C. Jail for the following charges:

Supplemental Report:

I am assigned to the Tustin Police Department's Special Enforcement Detail (SED). The SED team is assigned to southwest Tustin, as part of the area command to provide saturation patrol resources in high crime areas. Southwest Tustin is a high-crime area prone to murders, robberies, sexual assaults, assaults with deadly weapons, burglaries, stolen vehicles, gang activity, and drug activity.

Narrative:

On 04-24-13, Officer Girgenti and I were operating a marked police vehicle as a two officer unit. At approximately 2344 hours, Officer Girgenti and I responded to a patrol call for service reference a possible fight with gang type individuals in the area of midblock Myrtle St south of McFadden.

As Officer Girgenti and I arrived on scene, we were flagged down in front of [REDACTED] [REDACTED] I located the victim of an assault, who was inside [REDACTED] The victim identified himself as [REDACTED] [REDACTED]. I requested the Orange County Fire Authority respond to treat [REDACTED] for what appeared to be several abrasions on his left leg and a swollen left hand.

Detective Gomez arrived on scene and spoke to [REDACTED] reference the assault. See Detective Gomez' report for details.

On 04-23-13 at approximately 0120 hours, another call for service came out about a possible fight occurring in the same location on Myrtle St. The suspects involved in the incident fled southbound on Myrtle St. Detective Gomez and DPO Lopez were on scene within seconds of the call being dispatched. Detective Gomez and DPO Lopez quickly obtained information that the suspects fled to a second floor apartment on Altadena St. Detective Gomez later detained Marcos Cruz, Abel Andrade and [REDACTED] [REDACTED] inside of [REDACTED] as possible suspects related to the assault in which [REDACTED] was the victim.

DPO Arturo Lopez and I responded to [REDACTED] and re-contacted a witness to the original assault, [REDACTED] [REDACTED], to conduct an in-field line up. [REDACTED] spoke Spanish only and because of the language barrier DPO Lopez translated my conversation with [REDACTED]. DPO Lopez gave [REDACTED] an in-field line up advisement from my department issued card (In Spanish). [REDACTED] said he understood the advisement.

I had [REDACTED] sit in the rear seat of my police vehicle and drove him to the north alley of 17131 Alta Dena to conduct the in-field line up. Detective Gomez first walked Abel Andrade out in front of my police vehicle. I shined the vehicles headlights and spotlights

on Andrade in order to illuminate him so [REDACTED] could see him during the darkness. Within approximately two to three seconds of [REDACTED] looking at Andrade, [REDACTED] told DPO Lopez "That's him" in Spanish. [REDACTED] also told DPO Lopez that he was 100% sure that Andrade participated in the assault against [REDACTED]. [REDACTED] said Andrade was striking [REDACTED] with his hands during the assault and at one point told [REDACTED] the he was going to kill him.

Detective Gomez then placed Andrade in the rear seat of his police vehicle.

Officers Girgenti and Crouch then walked Marcos Cruz out in front of my police vehicle. [REDACTED] immediately said "Yes, that's one of them" in Spanish to DPO Lopez. [REDACTED] told DPO Lopez that Cruz is the subject that assaulted [REDACTED] with the "Block". [REDACTED] also told DPO Lopez that he is 100% certain that Cruz was involved.

Detective Gomez then walked [REDACTED] out in front of my police vehicle. [REDACTED] said [REDACTED] was not involved in the assault.

The entire in field line up was communicated in Spanish and translated to me by DPO Lopez who speaks Spanish.

The distance between [REDACTED] and the three subjects during the in-field line up was approximately 20 feet and illuminated using vehicle headlamps and vehicle spotlights.

I then transported [REDACTED] back to his residence and he was released.

I attempted to ask [REDACTED] questions about the incident but was unsuccessful because [REDACTED] primarily spoke Spanish. I observed the left side of [REDACTED]'s face appeared bruised and swollen. [REDACTED] had multiple left leg abrasions around his knee area and were actively bleeding. Detective Gomez and Deputy Probation Officer Art Lopez, who are both certified Spanish speakers, arrived on scene to assist with interviewing [REDACTED]. [REDACTED] informed Detective Gomez that three Hispanic males, ages 18-20 struck him with a brick and kicked and punched him repeatedly. Refer to Detective Gomez' narrative for further details.

I took photographs of [REDACTED] and his injuries and photographed the area the incident occurred. The photographs were later uploaded into a TPD computer database. I also collected a grey brick which [REDACTED] identified as the weapon used to strike him during the incident. The brick was later booked into TPD property as evidence. Refer to Detective Gomez' narrative for further details.

On 04-23-13 at approximately 0120 hours, another call for service came out about a possible fight occurring in the same location on Myrtle St. The suspects involved in the incident fled southbound on Myrtle St. Detective Gomez and DPO Lopez were on scene within seconds of the call being dispatched. Detective Gomez and DPO Lopez quickly obtained information that the suspects fled to a second floor apartment on Altadena St. Detective Gomez was able to determine the suspects ran into [REDACTED] [REDACTED] Officers Rojas and Crouch arrived on scene to assist.

Officer Crouch knocked on the door to [REDACTED]. A male resident answered the door and spoke with Detective Gomez. The resident allowed officers access into the apartment to look for the outstanding suspects, but none were located. DPO Lopez knocked on the door to [REDACTED]. A female resident answered the door and allowed TPD personnel into the apartment. Refer to Detective Gomez' narrative for further details. DPO Lopez, Officers Crouch, Jensen, Detective Gomez and I made entry into the apartment.

Upon entering the apartment, I observed a male subject, later identified as Marcos Cruz (06-02-91) sleeping on the floor of the main living area of the apartment. Cruz fit the description that [REDACTED] gave of the individuals that attacked him.

There was also another male subject, identified as [REDACTED], sitting in the living room next to where Cruz was sleeping. He also fit the description of a possible suspect, but was later determined not to be involved. Refer to Detective Gomez' narrative for further details.

Due to the fact that the suspects were possibly inside the apartment, coupled with the fact that the resident gave officers consent to search, DPO Lopez, Officers Crouch, Jensen and I then performed a safety sweep of the residence. During the safety sweep, I located a male Hispanic, who I recognized as Abel Andrade [REDACTED]. I have had prior contacts with Andrade and knew he is a self admitted member of the Lopers criminal street gang. Also, based on my prior contacts with Andrade, I know he is currently on CDC parole subject to search and seizure. A records check confirmed his parole status. Andrade also fit the description as a possible suspect.

Detective Gomez then spoke with Andrade about the incident. Andrade was later identified as a suspect in the attack during an Infield Identification. Refer to Detective Gomez' narrative for further details.

Detective Gomez then attempted to wake up Cruz so he could conduct an Infield Identification. Cruz eventually woke up so he could participate in an Infield Identification. Cruz appeared intoxicated and I detected the odor of alcohol emitting from his breath and person. Detective Gomez spoke with Cruz in Spanish. Cruz' words sounded slurred during the conversation.

Due to the geographic location of the second floor apartment where Cruz was located, and his level of intoxication, Detective Gomez and I had to assist Cruz to the location where the Infield Identification would take place. Detective Gomez held onto Cruz' left arm to assist him in walking while I held on to his right arm.

As Detective Gomez and I walked Cruz down a walkway leading to the stairs, he began to tense up and said something to Detective Gomez. I was unable to determine what Cruz said because he spoke in Spanish.

When we reached the top of the stairwell, Cruz became agitated and I felt Cruz' right arm tense up and he tried to escape my grasp. Cruz grabbed the stairwell railing with his hands and refused to walk down the stairs. Cruz then began twisting side to side attempting to break free of my hold on his right arm. Cruz was able to break free of my grasp and immediately began attacking Detective Gomez. Cruz struck Detective Gomez approximately two times on the left side of his face and head with a closed right fist.

I attempted to place Cruz in a "bear hug" style restraint hold to restrain his arms so he could not continue his unprovoked attack on Detective Gomez. I briefly was able to restrain Cruz in the "bear hug" but he was able to escape the hold.

Once Cruz escaped my "bear hug" restraint, he continued to fight and resist Detective Gomez and me. Due to the fact Cruz was actively engaging Detective Gomez in a fight; I struck Cruz approximately four times on his right side ribcage area with a closed right fist. At this point in the officer involved fight, it should be noted that the fight was taking place at the top of the stairwell and all three of us could have possibly fallen down the flight of stairs (approximately 20 stairs) which could have resulted in severe injury.

Detective Gomez and I decided to take Cruz to the ground to take him into custody and prevent anyone from falling down the stairs. When we hit the ground, I heard Cruz' head hit the floor, making a "Thump" sound.

Cruz continued to struggle with Detective Gomez and I while we were on the ground. I commanded Cruz to "Stop resisting" but he continued to fight with Detective Gomez and I.

I then struck Cruz with a closed right fist in the right ribcage area one time. Officers Jensen and Crouch arrived on scene to assist and Cruz was placed in handcuffs without further incident.

Officer Crouch and I walked Cruz out to the location for the Infield Identification without further incident. Cruz was positively identified during the Infield Identification. Refer to Detective Gomez' narrative for further details.

Recap (Original Report):

On Wednesday, April 24th, 2013, at approximately 2344 hours, DPO Lopez and I responded to 15917 Myrtle Av regarding an assault with a deadly weapon incident. We contacted the victim, [REDACTED] and he stated 3 suspects assaulted him after he declined to give them \$2 dollars.

[REDACTED] stated he was punched, kicked and struck with a large brick. He sustained several visible injuries to his face, arms, hands and his knees. The suspects fled the area and approximately two hours later they returned to the scene of the crime. This time, the suspects threw rocks at residents and flashed gang signs. The suspects fled on foot prior to our arrival.

A perimeter was established and air support was requested.

While searching for the suspects, DPO Lopez received information that two suspects were seen running inside a nearby apartment.

We contacted Abel Andrade and his associate, Marcos Cruz inside [REDACTED]. Both subjects claimed to have been inside the location at the assault. Andrade is a self admitted and active participant of the Lopers criminal street gang. Cruz has been previously contacted in company of Andrade.

Andrade and Cruz were identified via infield line up as 2 of the 3 suspects involved in the assault. Both suspects were arrested and booked at OCJ for:

I asked ██████████ if she could assist me by looking at some photographs and she said, "Yes." ██████████ told me she preferred our conversation to be in Spanish. Based on the fact I am a City of Tustin certified Spanish speaker, I spoke to her in Spanish.

I read ██████████ the Tustin Police Department Photo Line-Up admonishment from TPD Form (TPD 5071). ██████████ told me she understood the admonishment. She signed and dated the form in my presence.

6 Pack Lineup (Cruz):

I first showed ██████████ a 6-pack photo lineup depicting suspect, Marcos Cruz in the number 2 position. ██████████ looked at the line up and said, "I think I already saw one." ██████████ positively identified Cruz as one of the suspects who assaulted her husband. She circled and initialed Cruz' photograph.

I asked ██████████ if she remembered what Cruz was doing at the time of the assault. She said while she was at the top of the stairs she noticed Cruz at the bottom of the stairs wrestling with ██████████ and impeding him from running up the stairs. She said ██████████ was facing them as he defended himself with his arms and legs. She said Cruz picked up a concrete "Brick" and threw it at ██████████. She does not know if the "Brick" hit ██████████. ██████████ said "Brick" managed to hit her on her left foot. She sustained an abrasion on her left heel. Cruz and Andrade were last seen wearing white t-shirts. She described the white t-shirts as "tank tops."

6 Pack Lineup (Andrade):

I showed ██████████ a 6-pack photo lineup depicting suspect, Abel Andrade in the number 2 position. ██████████ looked at the line up and told me the second suspect was "This type" as she pointed to Andrade's photo as well as the photograph in the number 5 position. ██████████ told me "The two look like him," referring to Andrade's photo and the photo in the number 5 position. ██████████ took a closer look and told us she believed the subject in the number 2 position (Andrade) was the second suspect involved in the incident. She circled and initialed Andrade's photograph.

I asked ██████████ to describe Andrade's actions at the time of the assault. ██████████ stated she saw Andrade punch ██████████. I asked her if she heard the suspects say

anything during the assault. She said she just heard [REDACTED] pleading with them to "Calm down. My children are here."

She said since the incident every time [REDACTED] walks up to their apartment he "Quickly" walks upstairs and looks around to make sure he is not being followed. She said, "He is afraid."

I read [REDACTED] the Tustin Police Department Photo Line-Up admonishment from TPD Form (TPD 5071). [REDACTED] told me he understood the admonishment. He signed and dated the form in my presence.

6 Pack Lineup (Cruz):

I first showed [REDACTED] a 6-pack photo lineup depicting, Marcos Cruz in the number 2 position. [REDACTED] looked at the line up and pointed at Cruz' photograph positively identifying as one of the suspects who assaulted him. He circled and initialed Cruz's photograph.

I asked [REDACTED] to tell me what Cruz' actions were at the time of the assault. He told me he got a better look at the suspects when they were following him up the stairs. DPO Lopez asked [REDACTED] what role Cruz played during the assault. [REDACTED] said Cruz was one of the suspects who chased him and punched him.

6 Pack Lineup (Andrade):

I then showed [REDACTED] a 6-pack photo lineup depicting suspect, Abel Andrade in the number 2 position. [REDACTED] looked at the lineup and identified Andrade as the second suspect who assaulted him. He circled and initialed Andrade's photograph.

██████████ said Andrade was the first suspect to confront him. He said he eventually got into a physical confrontation with. I asked him if Andrade was the one who asked him for the \$2 dollars and he said, "No." ██████████ said prior to getting into a physical confrontation with Andrade he (Andrade) followed him while asking him, "What are you looking at?"

██████████ said he was not 100 percent sure Andrade was one of the suspects who assaulted him. I asked him how sure he was that Andrade was one of the suspects and he said, "I think that is him because he looked chubby."

██████████ told me he remembered fighting with Andrade in the area of Altadena Dr and Pasadena Av. He said while fighting Andrade another suspect he believed to be Cruz, tackled him from behind causing him to lose his balance and fall to the ground. ██████████ said he kicked one of the suspects and ran towards his apartment.

I asked ██████████ if remembered who threw the concrete "Brick" at him. He said he was not sure and was not sure if it hit him, but that it was possible. He said he did see the "Brick" land at the top of the stairs after striking ██████████ on her left foot.

I visually inspected and photographed ██████████ and ██████████ injuries.

6 Pack Line up (Ramirez):

I showed ██████████ a 6-pack photo lineup depicting, Alberto Ramirez in the number 2 position. Ramirez did not identify Ramirez as one of the suspects involved in the assault.

Brief Summary of Incident (Attach additional pages if necessary)

At 2344 hours, officers responded to the general vicinity of 15893 Myrtle regarding an assault that just occurred. Detective Gomez was assigned the investigation and he determined the victim was feloniously assaulted with a cinder block and three suspects were gone on arrival. The suspect(s) description was provided, along with a last known direction of travel.

At 0120 hours, officers returned to the location after the victim reported the suspect(s) returned and were challenging him to fight and were throwing "gang signs." Detective Gomez already had reliable information as to the identity of the suspects, as well as their probable location, which was [REDACTED]. Detective Gomez went to this location and he was accompanied by Officers Rojas, Crouch, Jensen, Girgenti and myself. Through Detective Gomez' investigation, he determined two suspects in the assault ran into apartment [REDACTED]. Officers received consent to enter from a female occupant and they located Marcos Cruz asleep inside. He was accompanied by [REDACTED]. Apartment [REDACTED] was an upstairs unit and it was not feasible for the victim to enter the apartment for an in-field identification. [REDACTED] was escorted downstairs, where the victim positively identified him as the assailant. [REDACTED] was subsequently arrested. Detective Gomez woke up Cruz in an effort to conduct an in-field identification. Cruz became verbally uncooperative. Based on the fact Cruz matched the description given by the victim, the fact he was accompanied by a known gang member [REDACTED] who was positively identified as one of the assault suspects, Detective Gomez attempted to escort Cruz downstairs for an in-field identification. Officer Girgenti

held Cruz' right arm as Detective Gomez held Cruz' left arm. Cruz began to stiffen his arms and he broke free of Girgenti's grasp and punched Detective Gomez in his face twice. Detective Gomez defended himself and punched Cruz in his face with his closed right fist. Cruz retaliated and punched Detective Gomez in his face several more times with his closed fist.

Detective Gomez and Officer Girgenti were outside of the apartment on a narrow upstairs landing, near the stairway, when this altercation occurred. Detective Gomez and Officer Girgenti feared they, or Cruz, could possibly fall down the stairs during the altercation and become injured. Detective Gomez and Officer Girgenti utilized their combined body weight and physically pulled Cruz to the ground in a "bear hug" to end the altercation. As a result, Cruz struck his face on the landing, causing a contusion to his right cheek. I was downstairs, out of view from the altercation. I heard a struggle and ran to their location, along with Officer Jensen. I went upstairs and saw Detective Gomez and Officer Girgenti attempting to gain control of Cruz as all three seemed to be struggling. Cruz' right arm was underneath his torso and he refused Detective Gomez' commands to free his arm. Officer Girgenti struck Cruz in his right side torso in an effort to gain control of his arm. Officer Crouch exited apartment [redacted] and officers were able to handcuff Cruz. Cruz was transported to WMSA, where he was treated for his injuries. ER staff determined Cruz had a minor orbital fracture to his right cheek. I interviewed Cruz in the ER and his statement was digitally recorded. Cruz stated he had been drinking approximately 18 Modelo beers and two 40 oz. Malt Liquors. Cruz stated he doesn't normally consume this amount of alcohol. Cruz stated he did not recall officers' waking him up or escorting him outside. The only thing Cruz recalled of the incident was sitting by the garage door in the north alley of Altadena. It should be noted, this was where Cruz was escorted after the altercation to be treated by OC Paramedics prior to being transported. Cruz attributed his alleged aggression to the alcohol and stated he respects the police and he would never assault an authority figure. Cruz denied being uncooperative or ever striking police personnel. I took digital photographs of Cruz' injuries.

Review/Comments:

Lieutenant/Manager: After reviewing the report and supporting documents prepared by Sgt. Cartwright, I find Officers Gomez and Girgenti acted appropriately during the incident. The suspect (Cruz) was wanted for a felony (Assault with a Deadly Weapon). Cruz assaulted Officer Gomez repeatedly and admitted he was intoxicated. I also reviewed the photographs which indicated the injuries were consistent with Cruz being "pulled" to the ground by the officers or being struck in the face with a closed fist.

The level of force was well within the guidelines set forth in our Department's Use of Force Policy . Given the facts and circumstances perceived by them at the time of the event, the Officers used the amount of force that appeared reasonably necessary to effectively bring the incident under control. As per our policy, the suspect was immediately treated for his injuries.




